**SUBJECT : REQUEST FOR STRINGENT PENAL ACTION AGAINST GOOGLE CORP. AND ITS DIRECTORS FOR ATTEMPTING TO TARNISH THE IMAGE OF THE PRIME MINISTER OF INDIA, AND FOR PROMOTING ENMITY AMONG GROUPS BY PUTTING OUT MISLEADING, MISCHIEVOUS INFORMATION IN THE PUBLIC DOMAIN AND THEREBY COMMITTING OFFENCES UNDER SECTIONS 153A, 500 AND 505 OF IPC.**

Hon'ble Prime Minister,

A few days back, Gemini, the Artificial Intelligence platform of Technology and Internet Company **GOOGLE** put out highly condemnable false information about Prime Minister of India in the public domain.

When it was issued a notice and it was pointed out to this company that it had violated India's laws by providing incorrect and misleading responses, the company tried to wash its hands off the matter and evaded responsibility. The company claimed that its generative Artificial Intelligence platform Gemini was built as a creativity and productivity tool and its responses may not always be reliable, especially when it comes to responding to some prompts about current events, political topics, or evolving news.

The company being the creator of the machine cannot be allowed to escape the consequences of the damage caused by the machine. The manner in which a machine is to learn facts and interpret them is designed by its programmer. If the programmer feeds a certain methodology to a computer, the computer will simply follow it and draw conclusions as dictated to it. The programmer cannot then distance himself with a disclaimer that the computer is acting on its own. As Henry Ward Beecher proclaimed, "a tool is but the extension of a man's hand". Just because a computer system is programmed on the lines of artificial intelligence, it does not imply that no person is responsible for what the machine
