- 3.2) The aforestated fact was therefore subsequently brought to the notice of Mr. Venegavkar, learned Advocate for Respondent Nos.3 & 4.
- Mr. Venegavkar fairly conceded to the fact that, no permission was granted to the said person for audio recording the Court proceedings. He fairly submitted that, the act of the said person cannot be justified. However, he requested this Court to show leniency to him as this is his first act and therefore may not to take stringent action against him. He thereafter on instructions from Mr. Sajid Abdul Jabbar Patel informed this Court that, for his said misconduct Mr. Sajid Abdul Jabbar Patel will pay a cost of Rs.1,00,000/- to the High Court Employees Medical Welfare Fund at Mumbai, within a period of three days from the date of uploading of the present Order on the official website of the High Court of Bombay. The said statement is accepted as an undertaking given to this Court.
