PROCEDURE COMMITTEE TO INVESTIGATE ALLEGATION
OF POSSESSION OF A FAKE LLB DEGREE CERTIFICATE BY
HON'BLE JUSTICE BIBHU PRASAD ROUTRAY, SITTING
JUDGE OF THE ORISSA HIGH COURT – UPHOLDING
JUDICIAL ETHICS, INTEGRITY, AND PUBLIC FAITH IN THE
INDIAN JUDICIARY

## Respected Lordship,

I, the undersigned, a concerned citizen and stakeholder in the integrity of the Indian judiciary, respectfully submit this petition under the plenary powers enshrined in Articles 124(4), 217(1)(b), and 235 of the Constitution of India, read with the <u>IN-HOUSE PROCEDURE</u> adopted by the Full Court of the Hon'ble Supreme Court to inquire into complaints against sitting High Court Judges. This representation is made in larger public interest, driven by the constitutional ideals of judicial accountability, transparency, and rule of law.

## **BACKGROUND FACTS:**

- 01. As per the records of the <u>Odisha State Bar Council, Enrolment</u>

  <u>No. O-1515-1994</u> pertains to Sri Bibhu Prasad Routray, S/o

  Jameswar Routray, R/o Village-Kanas, District-Puri, Odisha,
  born on 01.02.1970. Copy of the enrolment details is filed herewith
  and marked as ANNEXURE -01.
- 02. Justice Bibhu Prasad Routray was enrolled as an advocate on the strength of an LLB degree allegedly issued by ST. MARRY'S LAW COLLEGE, CANTONMENT ROAD, CUTTACK. A Law College that has never been recognized by the Bar Council of India (BCI), affiliated to any university, or approved by the Government of Odisha.
- 03. Justice Bibhu Prasad Routray entered judicial service as an Additional District Judge on 08th Dec 2008, rose through the ranks.
- 04. Justice Bibhu Prasad Routray was appointed as a Permanent Judge of the Orissa High Court on 07.11.2019 and continues to serve in that capacity. A copy of the Supreme Court's recommendation Dated 03.10.2019 regarding his appointment and the Ministry of Law and Justice (Department of Justice) Notification No. K.13027/02/2019-US.II dated 07.11.2019 are filed herewith and marked as ANNEXURE-02 and ANNEXURE-03, respectively.

## **CORE ISSUE:**

The legitimacy of Justice Bibhu Prasad Routray's LLB degree is under serious doubt, raising a fundamental question on the legality of his enrolment, judicial appointments, and ongoing tenure as a High Court Judge.

## **EVIDENCE RELIED UPON:**

1. The response of the Bar Council of India (BCI), conveyed through the Ministry of Law and Justice in reply to Unstarred Question No. 1018 raised by Shri Sukhbir Singh Jaunapuria and Shri Ramesh Bidhuri during the 11<sup>th</sup> Session of the 16<sup>th</sup> Lok Sabha and answered on 08<sup>th</sup> Feb 2017, pertains to the list of government law colleges, private law colleges and Universities in the country approved by the Bar Council of India as of 21<sup>st</sup> May 2016. Copy of the Lok Sabha Unstarred Question No. 1018 answered on 02.08.2017 (List of Affiliated Law College in India w.e.f 1947) is filed herewith and marked as ANNEXURE -04.

Pages 44 to 46 of Annexure A attached to the Minister's reply provide the complete list of BCI approved law colleges in Odisha.

2. The response of the Bar Council of India (BCI), conveyed through the Ministry of Law and Justice in reply to <u>Unstarred Question No. 2821</u> raised by Shri Alok Sanjar and Shri Sukhbir Singh Jaunapuria during the 11<sup>th</sup> Session of the 16<sup>th</sup> Lok Sabha and answered on 02<sup>nd</sup> Aug 2017, pertains to the list of government and private law colleges and Universities in the country approved by

the Bar Council of India as of 22<sup>nd</sup> Oct 2016. Copy of the Lok Sabha Unstarred Question No. 2821 answered on 02.08.2017 (List of Affiliated Law College in India w.e.f 1947) is filed herewith and marked as ANNEXURE -05.

Pages 34 to 35 of the Answer attached to the Minister's reply provide the complete list of BCI-approved law colleges in Odisha.

ST. MARRY'S LAW COLLEGE, CUTTACK, does not appear anywhere in this official list of approved college of legal education by Bar Council of India.

#### THIS IMPLIES:

St. Marry's Law College, Cuttack, lacks university affiliation, Bar Council of India approval, and government recognition.

Its LLB degrees are legally invalid under the Advocates Act, 1961. Any judicial or public appointment based on such a degree is prima facie illegal.

## **VIOLATIONS OF LAW & JUDICIAL ETHICS:**

- 1. Section 24, Advocates Act, 196 requires that only those with a law degree from a BCI approved institution may be enrolled.
- 2. In Bar Council of India v. Rabi Sahu & Anr, Civil Appeal No. 8571/2013, the Supreme Court held that degrees from unrecognized law colleges are void.
- 3. As reiterated in A.P. State Financial Corp. v. GAR Re-Rolling Mills and United India Insurance v. Rajendra Singh, any appointment obtained by fraud stands vitiated ab initio.
- 4. The Restatement of Values of Judicial Life (1997) obliges every judge to remain above suspicion. A forged academic qualification directly violates this standard.

#### **FAITH IN THE JUDICIARY:**

The judiciary is the bedrock of the Constitution. Public confidence in judges is essential for upholding the rule of law. Allowing this matter to go unexamined threatens the legitimacy of judicial institutions.

## PRAYER:

In light of the above, I most respectfully request Your Lordship to:

- 1. Refer this complaint to the Hon'ble Chief Justice of India for constitution of an In-House Procedure Committee to examine the authenticity and legality of the LLB degree held by Hon'ble Justice Bibhu Prasad Routray.
- 2. Debar Hon'ble Justice Routray from being assigned any judicial or administrative work in the Orissa High Court pending the outcome of the inquiry.
- 3. Direct an independent criminal investigation by the CBI into the role of the following authorities:
  - (a) Odisha State Bar Council, for unlawful enrolment.
  - (b) Government of Odisha, for failing in verification of credentials.
  - (c) Higher Education and Law Departments of Odisha, for regulatory lapse.
  - (d) OPSC, for not scrutinizing educational qualifications during OJS selection.
  - (e) Orissa High Court Collegium and State Government, for recommending elevation without due diligence.

4. Pass any such further order or direction as deemed just and necessary in the interest of judicial integrity, constitutional morality, and public trust.

## **CONCLUSION:**

This is not a personal attack, but a representation to protect the judiciary from fraudulent infiltration. Inaction would erode the foundational values of our legal system and embolden similar misconduct in the future. With faith in Your Lordship's commitment to justice and institutional probity, I submit this petition for immediate consideration.

## SUPREME COURT OF INDIA

The above recommendation made by the Chief Justice of the Orissa High Court on 7<sup>th</sup> May, 2019, in consultation with his two seniormost colleagues, has the concurrence of the State of Odisha.

In order to ascertain suitability of the above-named recommendees for elevation to the High Court, we have consulted our colleague conversant with the affairs of the Orissa High Court. A copy of letter of opinion of our consultee-colleague received in this regard is placed below.

With a view to assess merit and suitability of the above-named recommendees for elevation to the High Court, we have carefully scrutinized the material placed on record. The Collegium has taken note of the observations made by the Department of Justice in the file as well as complaints received against the above-named recommendees. Apart from this, we considered it appropriate to invite all the recommendees for interaction with the Collegium. On the basis of interaction and having regard to all relevant factors, the Collegium is of the considered view that Shri Bibhu Prasad Routray, Judicial Officer (mentioned at Sl. As regards S/Shri (1) Satya Narayan Mishra, (2) Gautam Sharma, and (3) Biranchi Narayan Mohanty, Judicial Officers, having regard to the material on record and all relevant factors, the Collegium is of the considered view that their cases deserve to be remitted to the High Court.
