**UPON hearing the counsel the Court made the following
O R D E R**

1. After hearing learned counsel for the parties and considering the prayers as made in the present Writ Petition in relation to the right of citizen for trauma

care, which may affect the personal liberty and for getting the equal opportunity in the situation as contemplated in the petition, it transpires that formulation of Standard Operating Procedure (SOP) in consultation with the State Governments may be appropriate.

2. After hearing learned counsel and Mr. Arijit Prasad, learned senior counsel, in this connection we deem it appropriate to request learned Attorney General for India to provide assistance of his good office in **scrutinizing** the stands of different State Governments and Union Territories and after an opportunity to the petitioners, he may submit a report with respect to the recourse which can possibly be taken in the facts and looking to the prayer made in the Writ Petition. In this view, we request learned Attorney General for India to take the lead and submit the report on the issues as raised within a period of six months from today.

3. On receiving the report, this Court may proceed further or to issue appropriate directions for

preparation of the SOP which may be commonly followed for the benefit of the citizens in the country by respective States and Union Territories.
