UPON hearing the counsel the Court made the following  
O R D E R

1. We have heard learned senior counsel for the petitioner as well as learned Additional Solicitor General of India on behalf of the State of Uttar Pradesh. The status report filed by the State has also been perused.
2. Learned senior counsel for the petitioner assures that unless granted express exemption by the Court, the petitioner shall appear before the Trial Court and shall fully cooperate for the expeditious disposal of the pending trials. In matters where petitioner has been granted exemption, it is undertaken that counsel for the petitioner shall remain present and shall fully cooperate with the Trial Court.
3. In light of the above-stated undertaking, we have no reason to doubt that the learned Trial Courts shall be able to proceed with the matters expeditiously and the prosecution will also ensure that the witnesses remain present for their examination.
4. As regard to the petitioner's prayer to relax condition no.6(iii) imposed on him while releasing him on interim bail vide order dated 07.03.2025, the petitioner is permitted to travel outside the State of Uttar Pradesh, provided that he shall furnish the particulars of the place of visit along with his contact number to one of the Investigating Officers and will further ensure that the trial proceedings shall not be hampered or delayed.
5. As regard to condition no.6(iv), it is clarified that it is only advisory in nature.
6. Similarly, condition no.6(i) is modified to the extent that if

the petitioner wants to stay at a place other than the official accommodation, he may inform such address to the local police and the Court concerned.
