UPON hearing the counsel the Court made the following
O R D E R

1. An issue has been raised before us regarding Bachelor of Commerce ("B.Com") degree possessed by the Petitioner being forged. Consequently, in that regard, on 01.08.2025, we had passed the following order:

"1. Pursuant to the order dated 09.05.2025, Bar Council of Punjab and Haryana has filed an interlocutory application no. 161167/2025 seeking permission to place on record certain additional documents. 2. Interlocutory Application No. 161167/2025 is allowed. The documents supplied alongwith aforesaid interlocutory application are taken on record.

3. Annexure A3 to the above interlocutory application is a letter issued by Controller of Examination, Magadh University, Bodh Gaya wherein it is stated that copy of Marksheet and Degree certificate in favour of Naresh Dilawari (Roll-PAT-16335, Regd No. 2870/88, B.Com. Accounts (Hons.), Examination 1991) upon verification was found forged and not issued from the University.

3. In such circumstances, we deem it appropriate to require the appellant to file photocopy of the Degrees under which he claims to be a Graduate in Commerce as well as in Laws.

4. List the matter after four weeks."

2. Pursuant to the above order, the petitioner has filed a photocopy of the degree issued to him for having passed the Bachelor of Commerce (Honours) examination of the three year degree course held in the month of August 1991 by Magadh University.

3. The learned Counsel for the Respondent has invited our attention to Annexure A-3 appended to I.A. No. 161167 of 2025 wherein the Controller of Examinations of Magadh University has reported that the mark-sheet and the B.Com degree espoused by the Petitioner is fake and forged and not issued from the University.

4. The Petitioner, on the other hand, has invited our attention to Annexure A-2 to the said I.A No. 161167 of 2025 to canvass that the records of the University were torn and, therefore, the degree may not be verifiable from the available records.

5. Be that as it may, as an issue regarding veracity of a degree has arisen, we deem it appropriate to require the Central Bureau of Investigation, Delhi to do the investigation and ascertain whether the degree set up by the Petitioner of having passed the B.Com examination from Magadh University in the year 1991 is genuine or forged.

6. Let a copy of this Order be sent to the Director of the Central Bureau of Investigation, Delhi who shall depute an officer to investigate into the above issue and submit report by or before 30.11.2025.

7. List this matter along with the report on 09.12.2025.
