UPON hearing the counsel the Court made the following  
O R D E R

We are not inclined to entertain this petition  
praying for bail. The special leave petition is  
dismissed accordingly.

However, considering the fact and circumstances of the case and the fact that the petitioner is in custody for more than 2 ½ years and further that 19 out of 64 witnesses are proposed to be examined by the prosecution, (from the 94 witnesses cited in the charge sheet), we direct the Trial Court to try and conclude the trial within a period of two years.

It goes without saying that the prosecution as well as the defence shall extend all cooperation in the conclusion of the trial.

In case the trial is not concluded within the aforesaid period, not for any fault of the petitioner or for no reason attributable to the petitioner, it would be open for the petitioner to revive his prayer for bail.
