ORDER

1. Learned counsel appearing for the respondent – husband submits that the name of the respondent has been spelled in the cause-title as “Pushpender Dagur” instead of “Pushpendra Dagur”. Hence, he seeks for same being corrected. Accordingly, he is permitted to correct the cause-title of the Transfer Petition.

2. Though this petition relates to transfer of a Divorce Petition filed by the respondent – husband, we had referred the matter at the joint request to the Supreme Court Mediation Centre to explore the possibility of settlement. Accordingly, the parties had appeared before the Supreme Court Mediation

Centre and same has been successful. They have entered into a settlement agreement dated 25.09.2025 which is forwarded by the Mediation Centre. Both the parties are present before the Court. In chorus, they would submit that after having understood the terms of the settlement, without any force, threat or coercion, they have voluntarily affixed their signatures out of their own will and volition. The respective learned counsels who are present before the Court have identified the parties who are present before the Court. A joint application has also been filed seeking for dissolution of the marriage that came to be solemnized between the parties on 28.11.2021.

3. Having regard to the settlement entered into between the parties and both parties being conscious of the terms of the settlement agreement and having agreed to part their ways, we see no reason as to why the settlement should not be accepted. Accordingly, it stands accepted.

4. Both the parties have filed an application for dissolution of the marriage for grant of a decree of divorce by mutual consent. The petitioner – wife, who is present before the Court

has acknowledged the receipt of a sum of Rs.17,00,000/- (Rupees Seventeen Lakhs) as permanent alimony in full and final settlement of all her claims and she has reiterated before this Court and she has no further claims against respondent or his family members and she gives up all her rights or claims against the respondent and his family members. Both parties agree and admit that there are no other matter/s or dispute/s pending before any other court except the petition filed for divorce in Family Main Case No.1847/2024 on the file of Family Court-01, Jaipur Metropolitan, Jaipur, Rajasthan.

5. Having regard to the fact that both the parties are educated and the chances of there reunion being remote and there being no possibility of such reunion as stated by them in their application for dissolution of marriage and reiterated before us, we see no reason as to why the power vested under Article 142 of the Constitution of India should not be exercised in the interest of justice and also in the interest of both parties. Hence, by exercising our power under Article 142 of the Constitution of India, the marriage solemnized between the

parties on 28.11.2021 stands dissolved by granting a decree of divorce by mutual consent and both parties have also admitted that there are no further claims against each other.

6. In view of the above, Transfer Petition is disposed of. The marriage between the parties stands dissolved and a decree of divorce by consent is granted and both parties are liberty to lead their future life without any reference to each other. Ordered accordingly. The decree of divorce may accordingly be drawn by the Registry of the Court forthwith.

7. Pending application(s), if any, shall stand disposed of.
