**UPON hearing the counsel the Court made the following  
O R D E R**

- 1) We have perused the report submitted by the National Highways Authority of India. However, during hearing, some recourse and the manner in which the compilations have to be filed has been discussed.
- 2) The first compilation shall consist of statutory provisions, including rules, regulations and guidelines, if

any. Second shall indicate the violation of those guidelines and correspondence thereto, if any. The third one shall indicate the persons responsible including the private persons due to whom the incidents may have been caused.

3) In addition, learned Solicitor General, learned *Amicus Curiae* and the counsels appearing may discuss the issues of public importance and guidelines suggested shall be filed.

4) In the meantime, parties are at liberty to exchange the google images or other documents with each other to identify the real problems on or before the next date.
