In view of the letter dated 15.05.2026 of Hon'ble the Chief Justice of India and the Office Memorandum dated 12<sup>th</sup> May, 2026 issued by the Government of India, Department of Personnel & Training, Govt. of India, the following austerity measures may be followed by the Officers/officials of High Court, Allahabad and its Lucknow Bench, with immediate effect:

1. To ensure optimum utilization of fuel, the Registry Officers of High Court, Allahabad and its Lucknow Bench have resolved to encourage car-pooling arrangements amongst themselves.
2. For all the staff (from Class-IV to Class-I) of High Court, Allahabad, Car/Vehicle pooling may be encouraged. Further they may also utilize public transport to the maximum.
3. All efforts be made to convene the meetings of the Hon'ble Committees comprising Chairman/members from Allahabad and Lucknow Bench, through V.C./online mode. To facilitate such meetings, co-presenting Officer may be appointed.
4. "Hybrid mode" may be adopted for conducting court proceedings, at the discretion of Hon'ble Courts/Judges. Accordingly the Ld. Counsels may be encouraged to appear for the cases, through Video Conferencing. For the purpose, the Office Bearers and Ld. Members of Bar/Advocates may be requested to make maximum utilization of Hybrid Mode through V.C.
5. There shall be a dedicated E-mail Id. and at least two helpline numbers to facilitate the above process mentioned at point no.04. The Registrar (J) (Computer), High Court, Allahabad is directed to do the needful in this regard.
